CVS/pharmacy. He is also an attorney and teaches law at Auburn University to 4th year pharmacy students. He explained that pharmacy laws differ from state to state and the way one pharmacist has been practicing for thirty (30) years might not necessarily be within the law. He recommended that the candidates become familiar with the Alabama Department of Public Health's Prescription Drug Monitoring Program (PDMP). Register and use the program to monitor patients and practitioners that might be diverting, abusing or misusing controlled substances. We rather you know if you are doing right. If something does not feel right, don't hesitate to call the Board office or even one of the Board Members.

Asking for questions from the candidates for licensure, there was one question if by obtaining a license starting this month, would candidate have to renew next month AND pay the renewal fee. **PRESIDENT CONRADI** asked the candidate if she was planning on practicing in Alabama before the first of the year and she said yes. Therefore, she will have to get a license for 2013/14 and renew it for 2015/16. The interviews concluded with **PRESIDENT CONRADI** welcoming each candidate to Alabama.

On a motion by **MEMBER BUDDY BUNCH**, second by **MEMBER DAVID DARBY** and a vote of ALL AYES, Alabama licensure was granted to the one (1) candidate for pharmacist licensure and she may pick it up before she leaves.
